

PROTOCOL LATIN DANCE COMPANY LOCATIE: BUURTHUIS DE KRAKELING

This protocol is in addition to the basic dance industry protocol version 2 October 2020. In this supplement, the application of the basic protocol will be explained specifically for the lessons of Latin Dance Company in Community Center De Krakeling and Theater Posa.

1. **Teachers wear a mouthcap** during the lesson as of 1-10-2020.
2. As of 12-10-2020, students are **required** to wear a **mouth mask** as soon as they enter the **Community Center**. This has been made mandatory by the city council. For **Theater Posa**, we still **recommend** wearing a mask during classes.
3. A maximum of 30 people may be present in the room, including staff.
4. If you have symptoms of a cold or have you been in contact with someone who has tested positive for Covid19 do not come to class.
5. The windows or doors are open for adequate ventilation in De Krakeling. Theater Posa has a special approved ventilation system.
6. The main entrance opens 10 minutes before the class and is only an **ENTRANCE** at the start of the lesson closes the main entrance. Theater Posa uses 1 in and exit to take into account each other passing at 1.5 m. distance.
7. The doors are open as much as possible to avoid contact with surfaces.
8. During class there is only entry allowed for registered dancers. So not for viewers.
9. Alle dancers are registered per lesson by an employee of LDC.
10. There is a disinfectant at the entrance so that hands can be disinfected before entering class.
11. Leaving the premises at the Krakeling can only open at the back **exit** at the end of the lesson and will close again 10 minutes after class.
12. The bar is open for ordering a drink but will close at 22:00.
13. There is limited space for sitting down in the bar and where up to 1.5 m distance is kept.
14. Before and after class, 1.5 m distance should be kept.
15. Only when you **take part in the class** the dance **partner's 1.5 m does not apply**.
16. Dance couples keep as much as 1.5m distance as possible.
17. Teachers dance alone with the teaching assistant and keep as good as possible 1.5 m away from the students.
18. During the **couple lessons we are NOT allowed to change**.
19. Toilet use is limited go to the toilet at home before class.
20. Leave the premises immediately after class.
21. During and after the class, door handles, toilets, chairs and tables are always cleaned..
22. A Corona employee will be present during the lessons to provide dancers with information.
23. Failure to follow the appointment of the Corona employee will follow a warning and if no instructions are repeatedly denied access to the lessons may be denied.

24. Upon finding Corona infection, all dancers who have been in contact with each other will have to follow the home quarantine rules. The rules also indicate that this can be done by your employer for your own leave account because one takes risks yourself.

Finally, we are very happy to be able to dance even though there are many rules.

We ask you to truly understand the rules, we will have to follow them. **Respect each other** and everyone's wishes in this. Remember you can't see how the health of the other person is.
